In light of the Disaster Declaration issued by the Governor of the State of Illinois relative to the COVID-19 pandemic, the Temporary Replacement Chairperson of the Joint Review Board has determined that an in-person meeting of the Joint Review Board, or a meeting conducted under the Open Meetings Act requirements relative to meetings at which members of the public body are participating remotely, is not practical or prudent because of the disaster.

At least one representative of the City and/or the Joint Review Board, or the attorney for the Joint Review Board, will be at City Hall. The virtual meeting will be able to be viewed at City Hall for members of the public who do not wish to view the virtual meeting from another location. Pursuant to the Executive Orders issued by the Governor, the number of people who may gather at City Hall for the meeting is limited due to the mandated social distancing guidelines. Accordingly, the opportunity to view and participate in the meeting at City Hall will be available on a "first come, first-served" basis and members of the public are urged to view and participate in the virtual meeting from an alternate location if possible.
