Excess power requirements will be handled on an individual basis.

PARKING SPACES: Up to two parking spaces will be provided for each vendor behind their tented space. The Committee will provide barricades and signs; however vendors are responsible for occupying and keeping their own spaces. Vendors must use assigned spaces for their vehicles and are not permitted to park along houses on the opposite side of the street.

The following will be required of all concessionaires:

1. No cold beverage of any kind will be served or sold.
2. All areas will be cleaned at the end of each day, and trash will be deposited in the dumpster provided. If, during the event, a receptacle becomes full, a Committee member or City personnel will be notified as soon as possible.
3. Nothing whatsoever will be taped or stapled to City owned tents or property.
4. All applications are due by June 5, 2026, with payment and insurance.
5. A \$50.00 late fee will be applied for any late applications after June 5, 2026.
6. ***Evidence of Liability Insurance naming Warrenville Friends of the 4th Committee, City Council and the City of Warrenville, 28W701 Stanford Pl., Warrenville, IL 60555 as additionally insured to be submitted WITH THE RETURNED APPLICATION to the address below***
7. All necessary certificates required by the City of Warrenville and the DuPage County Health Department will be obtained and conspicuously posted
8. All prices must be posted for food items and available for the public.
